Call to Order

Chairman Gouker calls the Ogle County Board Meeting to order at 5:32 p.m..

Roll Call

The roll call shows Nordman (5:35 p.m.) and Simms (5:46 p.m.) are absent. The Invocation is given by Chairman Gouker and is followed by the Pledge of Allegiance.

Approval of Minutes

Chairman Gouker asks for a motion to approve the October 21, 2014 Ogle County Board meeting minutes. Janes makes the motion to approve, Oltmanns seconds and the motion carries on a voice vote.

Approval of Reports

Chairman Gouker asks for a motion to accept the monthly report of the Ogle County Clerk & Recorder, Treasurer, and Circuit Clerk. Kenney moves to accept the reports as filed, Petrizzo seconds and the motion carries on a voice vote.(Placed on file)

Presentation – Blackhawk Hills Regional Council, Theresa Wittenauer, Executive Director

Theresa Wittenauer has distributed and reviews the 2014-2015 Development Guide and 2013-2014 Annual Report for the Blackhawk Hills Regional Council.

Welty comments on page 10 there is information regarding the Revenue and Expenses, but there is no balance sheet which shows Assets and Liabilities. Wittenauer states Julie at the office will have that information. Welty refers to page 13 and asks out of the \$360,573.64 how much was spent in Ogle County. Wittenauer replies she does not have that breakdown.

Colson asks Wittenauer to elaborate on the iFiber project in regards to the capacity that is available for private development. Wittenauer states there were 144 fibers with 48 for public sector and 96 for private and residential use.

Chairman Gouker thanks Wittenauer and the staff of the Blackhawk Hills Regional Council and comments Board Member Ron Colson is serving his second term as President on the council.

Presentation – Ogle County Emergency Management – Tom Richter

Tom Richter reports on the After Action Report from last year's Emergency Exercise. Richter states OCEMA does not handle emergency operations at an operational level, we assist the first responders in policy and financial oversight and resource management.

Richter states there was an exercise held in February 2014 and reports the exercise was a huge success. The purpose of the exercises is to find the holes that we have as first responders and managers along with our corporate partners. We will find where we are unprepared or where we need to correct action to be better prepared for the citizens of Ogle County.

Richter states he has a copy of the corrective action plan which notes some deficiencies. One item is we need to work on the public information flow in regards to pre-scripted messages and the information flow to the OCEMA Manager.

Chairman Gouker states these drills are designed to find errors and thanks Richter for the report.

Presentation – FY2015 Ogle County Budget and Appropriations – O-2014-1101

Chairman Gouker asks for a motion to approve the FY2015 Ogle County Budget and Appropriations O-2014-1101. Typer moves to approve O-2014-1101 and Oltmanns seconds.

Chairman Gouker states there are some changes to the Long Range Capital Expense Summary Plan which is the last page of the document:

Chairman Gouker states increases this year are about 3% average throughout the budget. The County Revolving Purchase Fund for the purchase of county vehicles it is in the second year and this is the second of four transfers. There will be some additional vehicles purchased again this year.

Chairman Gouker reads \$36,267,900.17 Fund Appropriations and \$7,463,530.00 Additional Fund Appropriations with a total of \$43,731,430.17 and the Levy is \$11,089,112.00. Chairman Gouker states on page 23 there are some funds listed which are grayed out and will be taken care of in the FY2016 budget.

Saunders is concerned about the \$40,000.00 budgeted for heating (#4214) when we have spent close to \$52,000.00 to date. Chairman Gouker states he recalls we have a new contract with NICOR. Gronewold states they did discuss this at the committee and were going to take some money from the electricity (#4212) since it was over budgeted; it must not have been addressed. We looked at the history and last year's weather as well. Griffin also states the new Sheriff and Coroner Building will be more energy efficient and should help with the budget.

- Colson notes any expenditures used from the Landfill money which is not new construction is under protest;
- Bowers abstains from General Fund Dept. 12 Sheriff and Dept. 22 Corrections as a family member is employed by the Sheriff's Department in Corrections;
- Saunders will be voting No on the entire budget; the transfer of funds from the Dependent Children's Fund to the General Fund without a separate County Board vote is not totally transparent without input from Judge Hanson and Director of Court Services Ken Burn. Chairman Gouker states Judge Hanson, Ken Burn and Matt Mekeel, the Focus House Director, are all onboard. This transfer will give the County Board a better understanding of what it costs to operate Focus House which gives it more transparency.;
- Kenney will be voting No on the budget as we are spending more than the revenue that is being brought in;
- Meyers asks how much has been spent on the new Sheriff and Coroner Administration Building. Griffin states \$4.3 or \$4.4 was been budgeted and we have spent approximately half so far. Chairman Gouker states this is what needed to be appropriated from the remainder of the \$4.3 million. Meyers asks about the furniture and Chairman Gouker asks if this can be addressed later in the meeting;
