**Call to Order**

Chairman Gouker calls the Ogle County Board Meeting to order at 5:33 p.m..

**Roll Call**

The roll call shows Petrizzo and Welty are absent. The Invocation is given by Bolin and is followed by the Pledge of Allegiance.

**Approval of Minutes**

Chairman Gouker asks for a motion to approve the December 1, 2014 Ogle County Organization meeting minutes. Griffin makes the motion to approve, McKinney seconds and the motion carries on a voice vote.

Chairman Gouker asks for a motion to approve the December 16, 2014 Ogle County Board meeting minutes. Janes makes the motion to approve, Nordman seconds and the motion carries on a voice vote.

**Approval of Reports**

Chairman Gouker asks for a motion to accept the monthly report of the Ogle County Clerk & Recorder, Treasurer, and Circuit Clerk. Bowers moves to accept the reports as filed, Heuer seconds and the motion carries on a voice vote. (Placed on file)

**Presentation – Serenity Hospice and Home – Executive Director, Lynn Knodle**

Executive Director Lynn Knodle introduces a woman to speak about her experience with Serenity Bereavement Services. Her experience with Serenity Bereavement Services was so beneficial; she has started a bereavement group for parents and grandparents of Ogle County. They now have people coming from Loves Park and Rock Falls to her bereavement group.

Sparrow states this is for presentation tonight and will be voted on at the February County Board Meeting.

- Tow Fund Recission – R-2015-0114

Sparrow presents R-2015-0114 to rescind the Administrative Tow Fund Transfer of \$61,713.12 from the Administrative Tow Fund into the General Fund which was passed by the board in October 2014. Hopkins seconds.

Saunders asks about the transfer of the IEMA Grant money that was deposited into the Tow Fund and should have gone into the General Fund. It was one of the first deposits into the Tow Fund and the check was for about \$13,000 and only \$10,000 was deposited. This was to pay for overtime due to a snowstorm that former Sheriff Beitel had applied for. Chairman Gouker states they will look into this and make the transfer at a later date if it is needed. Chairman Gouker states this transfer was to be done so the former Sheriff Harn could not appropriate the funds. Chairman Gouker states that would be a different action that would stand on its own and asks the Sheriff to look into it. Chairman Gouker asks the Sheriff to handle this at the County Security meeting. The motion carries on a voice vote.(Placed on file)

- Health Insurance Plan Amendment – R-2015-0109

Sparrow presents and makes the motion to approve R-2015-0109 for an Amendment to the County Health Insurance Plan to allow for the \$1,500 deductible which is now a second plan option. Sparrow states he believes 21 people have taken the \$1,500 deductible option. Nordman seconds and the motion carries on a voice vote.(Placed on file)

### **H.E.W. and Solid Waste:**

- Twenty-Year Update to the Ogle County Solid Waste Plan – presentation only

Bowers presents the Twenty-Year Update to the Ogle County Solid Waste Plan and has Solid Waste Director Steve Rypkema give a brief presentation. Rypkema gives a brief PowerPoint presentation on the document that is presented tonight.

Meyers asks how he plans to educate people on recycling. Rypkema states he has done newspaper articles, monthly radio ads, Facebook and Ogle County Webpage. It is an ongoing effort to use the tools we do have to educate people on the programs that are available. Meyers asks Rypkema about the recycling of the CFL light bulbs. Rypkema states his department accepts CFL light bulbs for recycling and refers Meyers to the Green Guide on the Solid Waste Department webpage for more information.

Chairman Gouker states there is a Resolution which has been presented and will be voted at the February County Board Meeting.
