### Call to Order

Chairman Barnes calls the Ogle County Board Meeting to order at 5:30 p.m.

### **Roll Call**

The roll call shows members Bauer and Messer are absent. The Invocation is given by Finfrock and followed with the Pledge of Allegiance.

# **Approval of Minutes**

Chairman Barnes asks for a motion to approve the October 18, 2011, County Board Meeting minutes. Heuer moves to approve, Bowers seconds and the motion carries on a voice vote.

Chairman Barnes asks for a motion to approve the October 26, 2011 County Board Budget Hearing minutes. Finfrock moves to approve, White seconds and the motion carries on a voice vote.

## **Approval of Reports**

Chairman Barnes asks for a motion to accept the monthly report of the Ogle County Clerk & Recorder, Treasurer, and Circuit Clerk. Kenney moves to accept the reports as filed, Janes seconds and the motion carries on a voice vote.(Placed on file)

## Presentation – Mike Mudge – Government Aggregation – O-2011-1201

Chairman Barnes asks Mike Mudge to address the board regarding Government Aggregation Ordinance 2011-1201. Mike Mudge is a representative of Rock River Energy and this Ordinance is asking to place a Referendum on the ballot to allow the County to operate the aggregation program. This will allow the residents of the unincorporated part of Ogle County to arrange the supply of electricity for its residential and small commercial retail customer who have not opted out of such a program. Mudge states in Ogle County the Village of Mt. Morris and City of Polo have passed this referendum.

Welty asks how many counties in the State of Illinois have passed the Ordinance. Mudge states Boone County and Stark County have at this time. Mudge states they have approached other municipalities and they are in various stages of review. Mudge states by December Ogle County maybe the first county in the state to pass this Ordinance countywide.

Welty asks how have the residents who are in the program been able to benefit from this savings. Mudge states they came back at about 25% savings on average of the Energy portion of the bill; which represents about 60% to 70% of the bill which is the power portion.

Welty asks Mudge how his company participates in the savings. Mudge states they are paid by the supplier no matter which supplier they use. The third party supplier must be licensed through the Illinois Commerce Commission.

Chairman Barnes states this Ordinance will be laid over until the December County Board Meeting.

## Presentation - FY 2012 Ogle County Budget & Appropriations - O-2011-1101

Chairman Barnes turns the meeting over to Finance Committee Chairman Gouker. Gouker has a couple of suggested changes:

- Page 1 Revenue Line Item 3125 Property Tax will be reduced to \$4,033,355
- Page 21 Solid Waste Line Item 4100 Salaries will be reduced to \$131,640

Saunders has concerns about the revenue estimate for zoning line item 3599 Other Licenses and Permits regarding the Baileyville Windfarm. We don't know if we are going to get the \$90,000 in revenue. Gouker asks Zoning Administrator Mike Reibel if the application fees for permits are reimbursable. Reibel states no they are not reimbursable once the permit is issued.

Kenney asks what the differences between the FY2011 and FY2012 budget are. Gouker states you can look at page 30 which is the comparison of Budgeted Appropriations and Levies from 2009 to current. Kenney doesn't like borrowing funds from other sources to cover our expenses.

Gouker did take the opportunity to talk to Rep. Pritchard about what the impact of legislation would have on us regarding the Personal Property Replacement Tax. Rep. Pritchard indicated he didn't think it would be a large amount. Gouker states there have been several Superintendents of

Schools that have resigned around the state. This particular fund is split in revenue and Cook County will share 52% and the rest of the counties will share 48% of the Personal Property Tax.

Welty as a member of the Finance Committee has a couple of comments regarding the budget process. There was a lot of discussion regarding the staffing levels and expenses. There is a \$752,131.61 increase in the General Fund and I don't agree with the funding of this. You will notice under the Long Range Planning Fund there is a transaction for \$500,000 which represents the service contracts for all of the departments throughout the county. These are service contracts which are ongoing annual service contracts. There is also a transaction in the amount of \$220,000 to fund utilities of county buildings. These are general operating expenses of the county and not related to infrastructure of the county; this is why I did vote against this at the Finance Committee meeting.

Gouker states the maintenance contracts are needed in order to keep the infrastructure we have in proper working condition. We should be developing a planned maintenance program for county buildings we have remodeled over the past decade and there are some buildings in need of repairs.
