#### Call to Order

Chairman Gouker calls the Ogle County Board Meeting to order at 5:30 p.m.

### **Roll Call**

The roll call shows Simms (5:39) is absent. The Invocation is given by Hopkins and asks that the Pledge of Allegiance is led by U.S. Army Veteran Brian Sawlsville. Chairman Gouker announces it is also Brian's Birthday today.

### Resolution – Sgt. Brian Sawlsville Day –R-2013-0815

Chairman Gouker asks Retired Brigadier General Steven P. Huber of Byron to read the Resolution which will be presented to Sgt. Brian Sawlsville in honor of his service to his country and declaring Brian Sawlsville Day in Ogle County. Sgt. Sawlsville says it does mean a lot for the recognition of his service and his community; thanks the County Board. McKinney moves to approve R-2013-0815 and Meyers seconds. Chairman Gouker states County Board member Meyers met Brian at a function at Focus House and wanted to recognize Sgt. Sawlsville for his service. The motion carries on a voice vote. ### Presentation – Business Employment Skills Team, Inc – Pam Furlan, Executive Director

Chairman Gouker introduces Pam Furlan, Executive Director for B.E.S.T., Inc. talks about the individuals enrolled in the Workforce Investment Act (WIA) services and hands out information regarding the businesses who are served through this program. Pam also introduces a success story of Daniel Gibble who was seeking services since he was laid off; he was a service manager of a local supermarket chain for 24 years. Daniel attended Highland Community College and received an Associate's Degree in Accounting with High Honors and a GPA of .367. Once obtaining his Associate's Degree he has decided to go on and receive his Bachelor's Degree. Daniel states financially he could not have gone back to school without this program. He asks the County Board to continue to support this program as it does help the constituents of Ogle County. Pam thanks Chairman Gouker and the County Board for all his support. Chairman Gouker states this program is funded by grants; there is no money from Ogle County.

# Presentation – Jarid Funderburg of Congressman Adam Kinzinger's Office

Chairman Gouker introduces Jarid Funderburg from Congressman Adam Kinzinger's satellite office in Belvidere. Jarid briefly explains services the office can help with in regards to: Capitol Flag requests, Grant Assistance, Internship opportunities, tour requests and help with Federal Agencies.

#### Planning & Zoning Committee:

• Status update - Muscarello Lawsuit and Baileyville Wind Farm Special Use Permit – Welty states the lawsuit was dismissed by the Judge on July 16, 2013 in the Federal Court. Welty states there was a meeting with himself, State's Attorney Mike Rock, Assistant State's Attorney Michael O'Brien and Zoning Administrator Mike Reibel to discuss the status of the Special Use Permit #9-12SU and it was decided that Reibel would send a letter to Apex Clean Energy, Inc notifying them that #9-12SU will expire on July 16, 2014 (one year from the dismissal of the Muscarello lawsuit) if significant progress was not made on that project. Welty also states the committee will ask a representative from Apex Clean Energy, Inc. to attend the October committee meeting to give an update on the project. Last week the committee was notified Muscarello has filed an appeal in the Federal Court.

# State's Attorney and Juvenile & Probation Committee:

Video Gaming Ordinance – O-2013-0801 - Chairman Gouker states at the Executive Committee there was discussion regarding the pros and cons to the Video Gaming Ordinance. There will be one person from each side to speak tonight and they will each have 5 to 7 minutes. Finfrock presents O-2013-0801 and makes the motion to approve O-2013-0801 and Sparrow seconds.

Anita Bedell, Executive Director of Illinois Church Action on Alcohol and Addiction Problems: This group opposes the expansion of gambling in the State of Illinois and especially concerned about the video gaming since it comes into each community. The machines are the problem and these machines are called the "Crack Cocaine" of gambling. Anita gives statistics regarding gambling, crime and revenue lost due to gambling.

Tom Green, representative from Blackhawk Music Co and Gold Rush Amusement of Sterling, Illinois – Tom says video gambling has been in Ogle County in various municipalities for about one year. There are economic advantages as the net profits from the gaming devices are split four ways - State gets 25 percent, the municipality or county gets 5 percent, and the establishment owner and owner of the machines each receive 35 percent. They have not experienced any crime at all. The screening process to get a video gaming license from the State of Illinois is very strict. They are making sure the people running the machines in the establishments are not criminals. The maximum bet is \$2 with the maximum prize of \$500. You can win more on a scratch-off lottery ticket than you can video gaming. These machines are not like the progressive machines in casinos.

Welty appreciates the opportunity to hear both sides of the video gaming issue tonight.

McKinney states video gaming is already in several cities and villages throughout the county; denying it to the businesses in the unincorporated areas of the county is unfair and puts them at a disadvantage.

Meyers is opposed to video gaming and states you cannot legislate morality.

Simms cannot support this ordinance because of the risk for what little revenue could be generated.

Oltmanns is also opposed to this ordinance; statistics show with video gaming there is an increase in domestic violence, foreclosures and other crimes. We would need to staff the sheriff's department for this increase and see this as a net-loss financially for the county.

Saunders states video gaming is already allowed in Ogle County, the costs are already here regardless. We are only talking about the unincorporated part of the county. Are we going to discriminate against the business owners outside of the city or village limits? Saunders will support this since she doesn't want to discriminate against businesses in the unincorporated areas. Saunders also states she finds the gaming devices irritating; the choice belongs to an individual who goes in to play. I believe in an individual rights and business owners rights and I will be voting to support it

Welty comments on the business owners rights and states the County Board has the responsibility to make decisions morally for the tax payers of the county.

Sparrow states Chairman Gouker has asked him to be the Economic Development Liaison for the communities in the county. With meeting with the businesses and trying to expand the economic base in the community; this is as though they are operating at a disadvantage if we don't pass this ordinance. There are 13 municipalities in Ogle County and 9 of them allow video gaming. Not passing this ordinance for the unincorporated area of the county is not going to stop the problems as the State has already approved this and is already in the county. All you are doing is denying the businesses in the unincorporated area of the county. This is an opportunity to attract customers. Sparrow states he will support this.

Gouker agrees with Welty and Meyers as this is harmful to the social fabric; however we do have businesses in the county and these liquor establishments are in the smaller unincorporated communities. Gouker asked State's Attorney Mike Rock to look at the State Statute to see if we have the ability to limit this based on sales. Rock stated he couldn't find anything that would specifically say we can't. It has been discussed in other communities but it could possibly lead to litigation. Gouker states he could only support this if we could add an amendment where 50 percent of the sales need to be generated from golf, food and liquor. There should also be a limitation on the signs for these establishments. Saunders states we do have sign limitations in our Zoning Ordinance. Sparrow would like to have State's Attorney Rock look into being more restrictive than the State and he doesn't see where we can be more restrictive than the State since we are not "Home Ruled." State's Attorney Rock states this was brought up in Loves Park and at the advice of their

counsel it was dropped; and he has not been able to find out why. County Clerk Huntley would like to know who is going to audit this information. Chairman Gouker states he does not want video gaming to be the primary business. McKinney states the City of Rochelle receives a monthly report from the State showing how much money was generated; you can obtain information from these reports.

McKinney makes the motion to amend O-2013-0801 and add Item 10: to include net profits of 50 percent of food, drinks, golf and gasoline and other non-gaming revenue and Gouker seconds.

Hopkins doesn't see how we are going to audit and see if a business is making a 50 percent profit on their business. Saunders states "total sales" does not mean "net profit" as the gaming machine may have a profit and the business could be losing money.

McKinney amends the motion to say: The establishment's gross revenues which would include video gaming profits must have at least more than 50 percent non-gaming revenue and Gouker seconds. A roll call vote is called:
